

Dear Colleague,

Happy New Year! I hope that 2022 will have started off well for you.

Just to “flag up” that our first Streatham Action Transport group meeting of the year will be taking place as planned next **Tuesday, 25th January, between 7 and 9pm on Zoom.**

I am pleased to confirm the following:

- **Bell Ribeiro-Addy**, MP for Streatham, will be joining us between 8 and 8.45pm to discuss with us the particular topic of Streatham’s rail transport infrastructure and how best for us all to work together to lobby for longer-term improvements for Streatham’s rail transport infrastructure, such as a previously-mooted Streatham interchange between Streatham and Streatham Common stations.
- **Simon Phillips**, LBL's Head of Transport Strategy and Programmes, will be joining us for the first part of the meeting between 7.15 and 7.45pm:
 - to provide us with a latest overview with regard to LTNs in Streatham - including the Brixton Hill LTN, which is now up for early-stage consultation until 4th February;
 - to discuss the *Peckham-Streatham Healthy Route* and the work about to be undertaken on Leigham Court Road to link the top of Leigham Avenue and the bottom of Mount Nod Road;
 - to hear from us, and discuss with us, any aspects surrounding traffic volume comparisons on the A205, on the section between Roupell Road and its connection with A23, between traffic levels on Tuesday 24th September 2019 and on Tuesday 28th September 2021*;
 - to provide us with any answers as yet gleaned from LBL’s Sustainability team as to why the pollution monitoring station on the corner of Palace Road and the A205 was removed and when.
- **Steve Fleming**, GTR's station manager for the 3 Streatham stations, will be attending between 7.45 and 8pm to update us on issues surrounding the ongoing amended timetables at our 3 Streatham stations and to provide us with an update on the Streatham station accessibility works.

*On Tuesday I received, from LBL, the Excel spreadsheet data for the now correct date in September 2021, Tuesday 28th, so as to allow for traffic levels on the A205 between Roupell Road and Christchurch Road’s intersection with the A23 to be analysed in comparison with Tuesday 24th September 2019. Our Vice Chair, Pete Johnson, is kindly now converting that comparative data in to a graph format, as he did also with the previous data. **I shall share that further information with all of us once it is available over the next day or so.**

I shall also, in a follow-up email over the next day or two, attach a copy of the agenda for next Tuesday's meeting, together with a copy of the draft minutes from our 7th December meeting.

An invitation to the meeting has also been extended to either or both of **Cllr Dr Mahamed Hashi** and /or **Cllr Danny Adilypour**, Joint Cabinet Members for Sustainable Transport, Environment and Clean Air.
